ENVIRONMENTAL AND BIODIVERSITY POLICY

- i) Train and enforce this policy is followed by all employees,
- ii) Adapt ISO 14001:2015 as the environmental management system framework in accordance with the best industry practices to identify, monitor, and mitigate environmental impacts while meeting socio-economic objectives,
- iii) Establish emergency plans relevant to hazardous substances released to the environment,
- iv) Provide funding for operation closure activities such that the environment could recuperate its vitality.
